WHEREAS, Midway Auto of Morganville, NJ was the highest bidder for 1986 International Dump Truck, 1991 International Dump Truck, 1994 Mack Water Truck, 2006 Ford Escape and the Cummins-model Generator; Marczaks Inc. of Metuchen, NJ was the highest bidder for the Plow/Frame; Liberty Motors of Jersey City, NJ was the highest bidder for the 1999 Chevy Tahoe, 2000 Ford Focus, 2004 dodge Durango, and 2006 Toyota Prius;
