**WHEREAS**, bids were received by the Township Manager on December 1, 2016 for the Solid Waste and Recycling Materials Collection Service; and

**WHEREAS**, Suburban Disposal Inc. of Fairfield, New Jersey was the lowest responsible bidder with a 2 year base bid of \$1,353,000.00 and the option of 3 additional years of service, on one year extensions as per the attached summary of bids; and

**WHEREAS**, the Township Engineer has made a recommendation dated December 2, 2016 that the Township award the contract to Suburban Disposal Inc.; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Aberdeen that the contract for Solid Waste and Recycling Materials Collection Service is hereby awarded to Suburban Disposal LLC of Fairfield, New Jersey commencing on January 1, 2021 and ending on December 31, 2021.

**BE IT FURTHER RESOLVED** the Director of Finance has certified to the Township Manager that there are available sufficient funds for the purpose of award of this contract in the 2021 Municipal Budget under the following line item appropriation of said budget to which this contract will be properly charged: 1-07-1-105-201 and 1-07-1-104-201.


