The Aberdeen Township Police made the following arrests May 3, 2017 through May 9, 2017:

- On May 3 a 45-year-old Sayreville man was arrested on a contempt warrant out of Aberdeen municipal court. P.O. Hank Chevalier was the arresting officer.
