The Aberdeen Township Police made the following arrests July 26, 2017 through August 1, 2017:

- On July 27 a 31-year-old township woman was arrested on a contempt warrant out of Aberdeen municipal court. P.O. Bruce Monro was the arresting officer.
- A 19-year-old Matawan man was charged with possession of marijuana and drug paraphernalia on Woodland Drive on July 28. A 17-year-old Old Bridge girl was charged with a curfew violation in the same incident. P.O.s Bruce Monro and Craig Hausmann were the arresting officers.
- Jason Zajaczkowski, 41, Aberdeen, was arrested on July 28 for criminal mischief following an incident on South Concourse. He was additionally charged with obstruction of justice and criminal mischief after he refused to cooperate with booking procedures and attempted to cause damage to a cell and a cell camera at police headquarters.
