

# ABERDEEN TOWNSHIP POLICE

## PRESS RELEASE

The Aberdeen Township Police made the following arrests November 22, 2017 through December 8, 2017:

- Elizabeth A. Belka, 28, Spring Lake Heights, was charged with driving while intoxicated, leaving the scene of an accident, and reckless driving following a motor vehicle crash at the Aberdeen train station on Atlantic Ave. on November 22. Other police activity during that period included:

- On November 28 a 2003 four-door Toyota Camry was stolen from the Aberdeen train station on Atlantic Ave. The victim was waiting for a friend and was out of the vehicle when a black male subject got into the car and drove away. The vehicle was recovered on the Matawan side of the train station parking lot on December 2. P.O. Anthony Marone investigated.
- On November 30 a 2017 Audi Q5 was taken from a driveway on Andover Lane sometime during the night. The vehicle was recovered in East Orange on December 3. P.O. Bruce Monro and Det. Louis Nanna investigated.
- On November 30 an Innerhill Lane resident reported that sometime during the night someone entered his unlocked vehicle and took his wallet. His debit card was later used to make unauthorized purchases and money transactions. P.O. Frank Maisano took the report.
- A resident of Inwood Place reported that in the morning of November 30 several subjects attempted to steal his 2013 Land Rover from his driveway. The perpetrators were unable to gain entry, but made similar attempts at neighboring vehicles. Surveillance video showed the three actors wore ski masks and gloves and may have been driving a Volvo SUV. Det. Louis Nanna investigated.
- On December 2 a resident of North Concourse reported the theft of mail. P.O. Bruce Monro responded.
- On December 4 the owner of Spiralseal on Cliffwood Ave. reported a front window of the business had been broken over the weekend.

Officers responded to or initiated 607 calls for service between November 22 and December 5, 2017, including 37 suspicious persons/vehicles; 35 alarms; 35 first aid calls; nine domestic violence incidents, 17 noise complaints, six disorderly persons, 18 motor vehicle crashes, one burglary, three criminal mischief incidents, two motor vehicle thefts, five thefts, seven frauds, seven welfare checks, five crisis intervention calls, and 173 motor vehicle stops. Officers issued 140 motor vehicle summonses.
