The Aberdeen Township Police made the following arrests December 6, 2017 through December 12, 2017:

- A 30-year-old Matawan man was arrested on a contempt warrant out of Aberdeen municipal court on December 8. P.O. Anthony Marone was the arresting officer.
- Richard Quitete, 35, Aberdeen, was charged with violation of a court order, obstruction of justice, and resisting arrest following an incident on Innerhill Lane on December 8. P.O. Bruce Monro was the arresting officer and Sergeants Matthew Lloyd and David Mauro assisted.
