

**ORDINANCE 13-2022**

BOND ORDINANCE REAPPROPRIATING \$718,500  
PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR  
ORIGINAL PURPOSES IN ORDER TO PROVIDE VARIOUS  
CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF  
ABERDEEN, IN THE COUNTY OF MONMOUTH, NEW  
JERSEY.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF  
ABERDEEN, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of  
all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$718,500 of  
the proceeds of obligations originally made available pursuant to the following bond ordinances  
of the Township of Aberdeen, in the County of Monmouth, New Jersey (the "Township") are no  
longer necessary for the various purposes for which the obligations previously were authorized:

Bond Ordinance #9-2020	The replacement of water mains on the easterly side of Atlantic Avenue from Church Street to 2nd Street, including all work and materials necessary therefor and incidental thereto, finally adopted September 17, 2020.	\$350,000

Section 2. The \$85,000 and the \$283,500 proceeds described in Section 1 and made available pursuant to N.J.S.A. 40A:2-39 are hereby reappropriated to provide for scanning and digitizing Township records for Police, Planning, Zoning, Purchasing, Assessor and Finance Departments (\$125,000), upgrades to the security doors at the Town hall (\$46,500), upgrades to the Town Hall, including, but not limited to, roof, lighting and electrical (\$166,000) and the acquisition of ride on mowers for the Department of Public Works (\$31,000). The \$350,000 proceeds described in Section 1 and made available to N.J.S.A. 40A:2-39 are hereby reappropriated to provide for improvements to the Noble Place water buildings and pump station, including, but not limited to, structural improvements, mold removal, making offices, and roof improvements.

Section 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
