The Aberdeen Township Police made the following arrests March 1, 2017 through March 14, 2017:

- Aamina Hutchinson, 22, was charged with aggravated assault and weapons offenses following an incident on Jersey Ave. on March 1. P.O. Edgar Serrano and Det. Louis Nanna investigated.

Officers issued 163 motor vehicle summonses.
