The Aberdeen Township Police made the following arrests February 28, 2018 through March 13, 2018:

- On February 28 Cody O'Donnell, 24, Keansburg, was arrested for simple assault and hindering his own apprehension related to an incident on Beverly Drive on November 12, 2017. Detectives Louis Nanna and Anthony Valentino were the arresting officers.

Officers responded to or initiated 650 calls for service between February 28 and March 13, 2018, including 27 suspicious persons/vehicles; 33 alarms; 27 first aid calls; four domestic violence incidents, seven noise complaints, eight disorderly persons, two burglaries, six thefts, 19 motor vehicle crashes, three frauds, four welfare checks, five crisis intervention calls, two criminal mischief incidents, and 146 motor vehicle stops. Officers issued 132 summonses.
