

## RESOLUTION 2022-131

WHEREAS, an emergency has arisen with respect to Warren Drive Sewer and, for which adequate provision was not made in the 2022 budget for the aforesaid purpose, and NJS 40A:4-46 provides for the creation on an emergency appropriation for the purpose mentioned above, and

WHEREAS, the total amount of the emergency appropriations created, including the appropriation to be created by this resolution is \$110,000.00 and three (3) percent of the total operating appropriations in the budget for 2022 is \$ 1,002,728.36

WHEREAS, the foregoing appropriation together with prior appropriations does ***not*** exceed three (3) percent of the total operating appropriations (including current and utility operation appropriations) in the budget for 2022,

WHEREAS, the foregoing appropriation will be funded through in full in the 2023 budget,

NOW, THEREFORE BE IT RESOLVED, (by not less than 2/3 of all governing body members affirmatively concurring) that in accordance with NJS 40A:4-48:

1. An emergency appropriation is hereby made for Warren Drive Sewer in the amount of \$110,000.00
2. That said emergency appropriation shall be provided for in full in the 2023 budget,
3. That two (2) certified copies of this resolution be filed with the Director of the Division of Local Government Services.
