The Aberdeen Township Police made the following arrests April 25, 2018 through May 1, 2018:

- On April 25 a 73-year-old Old Bridge woman was arrested for issuing bad checks at the Shop Rite store on Lloyd Rd. Det. Anthony Valentino was the arresting officer.

Officers issued 100 summonses.
