## **PRESS RELEASE**

The Aberdeen Township Police made the following arrests October 17 through October 23, 2018:

- A 36-year-old Aberdeen woman was charged with possession of marijuana and drug paraphernalia following a motor stop on South Atlantic Ave. on October 18. P.O. Raymond Campbell was the arresting officer with assistance from P.O. Mary Johnston.
- A 38-year-old Aberdeen man was charged with possession of marijuana on October 18. Det. Anthony Valentino was the arresting officer.
- P.O. Michael Monteiro arrested a 28-year-old South Amboy man on a contempt warrant out of Aberdeen municipal court on October 19.
- A 17-year-old Aberdeen youth was charged with possession of marijuana and possession of marijuana with intent to distribute following a motor stop on Cliffwood Ave. on October 20. Special Officer Brian Mason was the arresting officer.
- P.O. Martin Walsh arrested a 55-year-old Elizabeth man on a warrant for parole violation out of Woodbridge following an incident on Barbara Place on October 22.

Based on surveillance video, the perpetrators were driving a late model four-door Nissan Altima or Sentra, gray or charcoal in color, with out-of-state registration. The passenger of the vehicle appears to have been a male with a dark complexion wearing blue jeans, a camouflage hooded jacket

Officers responded to or initiated 273 calls for service between October 17 and October 23, 2018, including six suspicious persons/vehicles; 16 alarms; 19 first aid calls; four domestic violence incidents, two burglaries, three thefts, four noise complaints, eight disorderly persons, one fraud, six motor vehicle crashes, two crisis intervention calls, and 90 motor vehicle stops.
