The Aberdeen Township Police made the following arrests January 3, 2018 through January 9, 2018:

- A 47-year-old township man was arrested on a contempt warrant issued by Ocean County Superior Court after he was located on Smith Court on January 3. P.O.s Mohamed Mahmoud and Raymond Campbell were the arresting officers.
- A 52-year-old township man was arrested on contempt warrants out of Woodbridge and Rahway municipal courts following an incident on Lower Main St. on January 3. P.O. Bart Szulczynski was the arresting officer.
- A 19-year-old township man was arrested on a contempt warrant out of Hazlet municipal court following a motor vehicle stop on Hwy. 35 on January 3. P.O. Ronald Osadacz was the arresting officer.
- P.O. Heather Dillon arrested a 31-year-old township man on a contempt warrant out of Marlboro municipal court on January 7.
- P.O. Darryl Richardson arrested a 36-year-old township man on a contempt warrant out of Englishtown municipal court on January 9.

Other police activity during that period included:

- Officers responded to 10 motor vehicle crashes over the two-week period. The locations were: Atlantic Ave. (2), Hwy. 34/Lloyd Rd., Hwy. 35/Cliffwood Ave., Matawan Ave./Dogwood Lane, Lloyd Rd./Church St., Lloyd Rd./Ivyhill Drive, Drexel Lane, and Ingram Circle. The other was in a parking lot.
- On January 4 a County Rd. resident reported he gave personal information to an individual purporting to offer him a pre-approved mortgage. P.O. Bruce Monro took the report.
- On January 6 the owner of a sandwich shop under construction on Hwy. 35 reported that someone entered the premises and damaged a mural on one of the interior walls. P.O. Anthony Marone responded.
- On January 8 a resident of Aberdeen Station apartments, Central Ave., reported she had placed an ad on Craigslist and was contacted by an individual who subsequently sent her a check with instructions to deposit it, keep a percentage, and send the balance to him. The victim recognized this as a scam and reported it to police. P.O. Heather Dillon took the report.

Officers responded to or initiated 306 calls for service between January 3 and January 9, 2018, including ten suspicious persons/vehicles; 30 alarms; 15 first aid calls; one domestic violence incident, six noise complaints, four disorderly persons, ten motor vehicle crashes, three frauds, two welfare checks, four crisis intervention calls, one criminal mischief incident, and 50 motor vehicle stops. Officers issued 106 motor vehicle summonses, including 56 for vehicles parked on the street in violation of the snow removal ordinance.
