PRESS RELEASE

The Aberdeen Township Police made the following arrests May 1st through May 31st, 2020:

- On May 11th, a 51 year-old Aberdeen Township male was charged with violation of a TRO following an incident on Woodmere Drive. Ptl. Evan Guastafarro and Jeff Griffith were the arresting officers.
- On May 11th, a 26 year-old Tinton Falls Borough male was charged with possession of CDS (Marijuana) and contempt of court on warrants issued by Monmouth County Sheriff's Office and Tinton Falls Municipal Court. Ptl Bruce Monro and Michael Monteiro were the arresting officers.

Officers issued 118 summonses on 32 motor vehicle stops.
