

RESOLUTION NO. 2024-118

WHEREAS, an emergency has arisen with respect to water main breaks and fire hydrant break due to car accident , no adequate provision was made in the 2024 budget for the aforesaid purpose, and NJS 40A4-46 provides for the creation on an emergency appropriation for the purpose mentioned above, and

WHEREAS, the total amount of the emergency appropriations created, including the appropriation to be created by this resolution is \$37,297.09 and three (3) percent of the total operating appropriations in the budget for 2024 is \$ 985,648.37

WHEREAS, the foregoing appropriation together with prior appropriations does not exceed three (3) percent of the total operating appropriations (including utility operation appropriations) in the budget for 2024,

NOW, THEREFORE BE IT RESOLVED, (by not less than 2/3 of all governing body members affirmatively concurring) that in accordance with NJS 40A:4-48:

1. An emergency appropriation is hereby made for Water Main Break and Fire Hydrant repair in the amount of \$37,297.09
2. That said emergency appropriation shall be provided for in full in the 2024 utility budget
3. That two (2) certified copies of this resolution be filed with the Director of the Division of Local Government Services.
