

## **RESOLUTION NO. 2025-84**

### **A RESOLUTION AUTHORIZING THE TOWNSHIP OF ABERDEEN TO ENTER INTO A SHARED SERVICE AGREEMENT WITH THE COUNTY OF MONMOUTH THROUGH THE MONMOUTH COUNTY SHERIFF'S OFFICE FOR TO PROVIDE PUBLIC SAFETY ANSWERING AND DISPATCH SERVICES**

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et. Seq., (the “Act”) provides that any governmental unit may enter into a contract with any other local governmental unit to provide or receive any service that each local unit is empowered to provide or receive within its own jurisdiction; and

**WHEREAS**, the Township of Aberdeen (the “Township”) and Monmouth County (the “County”) through the Monmouth County Sheriff’s Office (the “Sheriff’s Office”) (Collectively the “Parties”) entered into an Agreement to which the County and Sheriff’s Office will provide Dispatch Services to the Township (“Shared Services Agreement” or “Agreement”); and

**WHEREAS**, the Parties have agreed to enter into the Agreement for a term of five years, commencing on September 1, 2025, through December 31, 2030; and

**WHEREAS**, the Parties deem that a Shared Services Agreement for the purposes expressed herein is in the mutual interest of all parties and is also in the public interest such that sharing of these services will promote the public health, safety, and welfare.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Aberdeen that it hereby authorizes execution of the Shared Services Agreement between the Township of Aberdeen and the County of Monmouth and the County of Monmouth Sheriff’s Office.

**BE IT FURTHER RESOLVED** that the Township Council of the Township of Aberdeen hereby authorizes the Township Manager and Municipal Clerk to execute said Shared Service Agreement on behalf of the Township Council of the Township of Aberdeen. A copy of the Shared Service Agreement and this Resolution will be placed on file in the office of the Municipal Clerk.

- c. The County of Monmouth’s Sheriff’s Office
