

RESOLUTION NO. 2016-37

WHEREAS, the Township of Aberdeen, as a contractor unit, may, without advertising for bids, purchase any materials, supplies or equipment under any contract or contracts for such materials, supplies or equipment entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury to the provisions of N.J.S.A. 40A:11-12; and

WHEREAS, the Township Council desires to enter into an agreement with the State Contract vendors on the attached list, which agreement shall be subject to all the conditions applicable to the current State Contract; and

WHEREAS, the Township Council desires to authorize the Manager/Purchasing Assistant to purchase those items for the approved New Jersey State Contract vendors and Monmouth County Co-Ops as per attached list for the year 2016.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Aberdeen that the Township Manager/Purchasing Agent are authorized to make such purchases for the attached list of vendors in accordance with N.J.S.A 40A:11-12 for the year 2016.

BE IT FURTHER RESOLVED, that pursuant to the rules of the Local Finance Board of the State of New Jersey, no amount of this contract shall be chargeable until a certification of available funds is made and a properly executed purchase order is received.

BE IT FURTHER RESOLVED, that said authorization shall not expire with the current Vendor's State Contract, but shall extend until the new State Contracts are issued, which shall be updated and made part and parcel of this Resolution.
