

RESOLUTION NO. 2016-107

WHEREAS, Parkside Manor has requested the release of performance guarantee posted on property located at 768/770 Shore Concourse, Block 327, Lots 16.01 and 16.02 on the Official Tax Map of the Township of Aberdeen; and

WHEREAS, the Township Engineer has recommended release of performance guarantee in a letter dated June 13, 2016.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Aberdeen that it hereby authorizes release of performance guarantees: Bond #71676487 in the amount of \$23,819.40, Bond #71677274 in the amount of \$4,871.70 and cash bond in the amount of \$2,646.60 in accordance with the June 13, 2016 recommendation of the Township Engineer.

BE IT FURTHER RESOLVED that the release of the aforesaid bond is subject to the posting of a two year maintenance bond in the amount of \$8,841.60, payment of any outstanding inspection and professional fees and concurrence by the Township Manager and Township Attorney, maintenance bond is not required.

As per the developer's request of May 3, 2016, we have reviewed the above referenced project for completion of all site improvements as required by the Board's approval. We find that all improvements have been installed as required. Accordingly, we can recommend release of the existing performance guarantees, subject to the Applicant posting a two-year maintenance guarantee as follows:

Schedule A: \$26,466.00 X 0.15 = \$3,969.90
